Please note, it is our strict policy to not refund fees. The reservation process is an essential part of ensuring a successful show, both from the perspective of our vendors and of our customers. These fees help ensure all of our spaces will be occupied and cover the cost of the facility rental. **In the event of inclement weather, the show organizers will decide at their own digression whether the show shall take place. If the show is postponed due to weather, the application fee will be transferred only – no refund will be given.** Please do not leave early without speaking to the organizers. Please try to be out of the venue 1 hour after the show. After you unload your merchandise, please move your vehicle as far away from the venue as possible to allow for more customers. **Show organizers are in no way responsible for accidents or theft before, during, or after any show, and you understand that show organizers do not insure any vendor or their merchandise.** All vendors will need to submit a small door prize for this show to be held at their booth.
